

Regulations of the Kids Run during the event under the name DOZ Maraton Łódź 2022

The content of these Rules of Procedure shall apply from 29 April 2021.

The Kids Run (hereinafter: Run) takes place as part of the event called DOZ Maraton Łódź 2022 (hereinafter: DOZ Maraton Łódź 2022):

I. Organizer, Contractor and Run's Partners

1. The Organizer

Association "Maraton Dbam o Zdrowie"; with its seat in Łódź, 3 Zbąszyńska Street, 91-342 Łódź, entered in the Register of Associations, Other Social and Professional Organisations, the Foundation, and Independent Public Health Care Centres run by the District Court for the Republic of Poland for Łódź-Śródmieście in Łódź Economic Court XX Economic Division of the National Court Register under KRS number 0000403717, REGON: 101325327, NIP: 9471980735.

2. The Contractor

Ms Joanna Chmiel running the company under the name Beauty Sport Run Joanna Chmiel with the registered office in Łódź at Konstadta Street 7 m. 66, 91-430 Łódź, NIP 7271445611, REGON 364956765.

The Organiser entrusts the Contractor with the execution of the event under the name "DOZ Maraton Łódź 2022"; together with accompanying events on 22-24 April 2022, in particular the Kids Run.

3. Strategic partner

II. The purpose of the Run

The purpose of the Run is:

- popularization of running as the simplest form of physical activity among teachers and children and schoolchildren,
- promotion of sport in various age, social and environmental groups,
- promotion of sport in schools and families,
- promotion of the City of Łódź and the Łódź region in Poland and worldwide.

III. Name, date and place of the Run

Name: DOZ Maraton Łódź - Kids Run

Deadline: 23 April 2022. (Saturday)

Place: Atlas Arena, Łódź, Al. Bandurskiego 7 (start, finish, competition office)

Starting time: from 10:00 a. m. , according to the Event's schedule.

IV. Route

1. The race will take place at different distances depending on the age of the Participants.
2. The course of the Run will be supervised by judges of the Polish Athletics Association.
3. The Run route will be marked out in and around the Atlas Arena at Al. Bandurskiego 7 in Łódź.
4. The route of the race will be published on the website www.lodzmaraton.pl by 31 March, 2022 r.

V. Terms and conditions of participation and race schedule

1. Each age category of the Run has a registration limit of 70 people.
2. The schedule of starts of particular age categories of the Run on April 23, 2022:

 - 10:10 a. m. - boys'; race start: years 2005 and 2006
 - 10:20 a. m. - girls'; race start: year 2007

 - 10:50 am - boys'; race start: year 2008
 - 11:00 a. m. - girls'; race start: year 2009
 - 11:10 a. m. - boys'; race start: year 2009
 - 11:20 a. m. - girls'; race start: year 2010
 - 11:30 a. m. - boys'; race start: year 2010
 - 11:40 a. m. - girls'; race start: year 2011
 - 11:50 a. m. - boys'; race start: year 2011
 - 12:00 p. m. - girls'; race start: year 2012
 - 12:10 p. m. - boys'; race start: year 2012
 - 12:20 p. m. - girls'; race start: year 2013
 - 12:30 p. m. - boys'; race start: year 2013

 - 1:50 p.m. – boys', race start: years 2017 and 2018
3. Any person born in a given year may participate in the Run, in accordance with the age categories of the Run, as referred to in section 2 above.
4. Each Run Participant must be registered in the Run by a parent or guardian by completing the online application form available on the website www.lodzmaraton.pl until 15 April 2022 or in person in the race office on 22 April 2022 (unless the application limit is exhausted by 15 April 2022)
5. On the Run Day (23 April 2022) there will be no possibility to register. On that day, the competition office will only issue bib numbers and starter kits.
6. Any changes in the notifications (e. g. change of names, submission of a package) will not be carried out after 15 April 2022.

7. The condition for participation in the Run is to register electronically on the following website www.lodzmaraton.pl until 15 April 2022 or in person in the competition office on 22 April 2022 (unless the application limit is exhausted by 15 April 2022), as well as the payment of the entry fee in accordance with the price list referred to in point VI of this document Rules of Procedure.
8. Failure to pay the participation fee referred to in point VI of these Rules and Regulations above shall result in the following failure to assign a starting number to the Run Participant and inability to participate in the Run.
9. Only participants with paid participation and assigned starting numbers have the right to start in the Run.
10. The parent or guardian of the Run Participant who registered the Run Participant, but, by the 15 April 2022, has not paid the participation fee, must re-register the Participant for the participation in the competition, in person in the Run Office on 22 April 2022, unless the limit for submissions has been exhausted.
11. Each parent or guardian must personally collect the number and starting package of the Runner. on 22-23 April 2022 in the running competition office.
12. The parent/guardian must present their own identity document when collecting the start number.
13. If the number and starter package cannot be collected personally, the parent/guardian may authorize an attorney of full legal age.
14. The condition for the receipt of the starter pack and the bib number by the proxy is to show an authorization signed by the Participant and the photocopy (for inspection only) of the Participant's identity document with the photo in the Run Event Office. Content of the authorization will be available on www.lodzmaraton.pl in the "Documents to download" tab.
15. Each Runner must run with a starting number assigned by the Organizer positioned in a conspicuous position at the front.
16. During the race, each Participant is obliged to have a bib number pinned horizontally to the front of the shirt (or outdoor clothing). The bib number must be visible during the whole race.
- 17. Under the penalty of disqualification, it is prohibited to cover the bib number in part or in the whole, or to modify it.**
18. Parents/guardians take full responsibility for the participation of the child/charge in the Race, being aware of the current state of health of the child/charge. The organizer recommends parents/guardians to conduct medical examinations of the Runners in connection with the intention to participate in the Run and not to apply for participation in the Run in the event of medical contradictions. The Organizer shall not be liable for the consequences of participation in the Run of Participants whose health condition constitutes a contraindication to participation in the Race. The organizer does not verify the health of Participants. Parent/guardian of the Participant through his/her application acknowledges this and assumes full responsibility for the Participant.
19. Providing the Organizer with a correctly filled in application form, paying the entry fee and consent to the participation of the minor means that the parent/guardian has considered and assessed the nature, extent and degree of risk associated with the participation of the child/charge in Run, including the risk of accidents, potential personal and physical injuries, including death, as well as property damage and voluntarily decided to undertake the risk.
20. The Runners are obliged to run only along the route marked out by the Organizer.

21. The Runners are obliged to absolute submission to recommendations of the municipal services, i. e. the Police, the Municipal Guard and the Organizer's enforcement services as well as judges and other services securing the route of the race during the Run.
22. Medical service decisions regarding the continuation of the race by the Participant to whom it has been assigned the aid granted is definitive and indisputable.
23. The participation of the Runners is the full responsibility of their parents or guardians.
24. The collection of the bib number and participation in the Run is tantamount to getting acquainted by the parent/guardian with the rules of the Run and the obligation to comply with its provisions.
25. The packages and bib numbers will be issued in the Run Office. The Run Office will be located in the Atlas Arena at Bandurskiego Avenue 7 in Łódź and will be open on the following days and hours:
 - 22 April 2022 (Friday) between 1:00 p. m. and 8:00 p. m.;
 - 23 April 2022 (Saturday) from 8:00 a. m. to 30 minutes before the start of the race of a given category of age. After this time, issuing packages and bib numbers for a given category of age is ended.
- 26. On the Run day, i. e. 23 April 2022, registration for the Run will not be conducted. On that day you will only be able to pick up the package and the bib number.**
27. The results of all Runners at the finish line will be calculated according to the gross time, i. e. the time of counted from the moment of firing the starter until the moment of crossing the finish line.
28. Before and after the Run, Participants will have the possibility to use a changing room.

VI. Starting fees

1. The entry fee for participation in the Run should be paid electronically via the "Go to Payment" option, available on the website www.lodzmaraton.pl
2. Starting fees for the Participants who will be registered for the Run in the Race Office on 22 April 2022 (if places are available) will be paid in cash only. There won't be card payment options.
3. Participants who want to pay online via the form application available on the website www.lodzmaraton.pl can use credit and debit card.
4. Parent/guardian of the Participant who wants to receive an invoice for the participation fee of the Runner, is obliged to provide in the application form accurate data to issue invoices. In case of failure to provide invoice data or incomplete data, no invoice will be issued. The invoice shall be issued by the Organizer.
5. The participation fees:
 - I term - payment made by 15 April 2022 - 30 PLN
 - II term - payment in office made on 22 April 2022 - 40 PLN
5. The evidence of payment of the fee is the appearance of the bib number next to the Participant's name on the start list on the website www.lodzmaraton.pl.
6. If after 7 (seven) days the bib number does not appear, the parent/guardian of the Run Participant is obliged to contact the Organizer by e-mail: stowarzyszenie@pelion.eu.
7. Once paid, the fee cannot be returned or transferred to another Run Participant or another race held by the Organizer.
8. The Organizer has the right to exempt selected Runners from the entry fee.
9. The entry fee paid for a Participant will not be returned if the Participant resigns. The relinquishing and resale of a bib number is also prohibited without the Organizer's consent. The fee shall be refunded only in exceptional and justified cases at the request of a participant.
10. There is no possibility of an anonymous start in the Run.

VII. Starting package

1. Each Runner receives a T-shirt, bib number and safety pins in the starter package, gifts and gadgets of the Run sponsors, water at the finish line, and additionally - in case of consent of the parent/guardian in the application form - also the result achieved in the Run which will be sent to the telephone number provided by the parent/guardian in the application form.
2. Each participant who completes the Run will receive a commemorative medal at the finish line.
3. The Organizer does not accept private supplements/water bottles from the participants

VIII. Awards in the Run

1. Detailed information on the prizes in the Run will be published in the "Awards" section of the www.lodzmaraton.pl website not later than on 31 March 2022.

IX. Personal data

1. The administrator of personal data provided in connection with the registration of participation in the Run is Association "Maraton Dbam o Zdrowie" Zbąszyńska St.3, 91-342, Łódź.

2. Legal basis and period of processing personal details in particular cases is as follows:

- **The purpose of processing details:** execution of the agreement between the parties (Regulations)

Legal basis: processing is necessary for the performance of a contract to which the data subject is a party (art. 6 § 1b GDPR)

Processing period: 1 year after the end of the event, and after that time, if this is required or permitted by law, e. g. in order to assert any claims.

- **The purpose of processing details:** communication for the purpose of performing the contract with a person other than the one with whom the contract has been concluded, e.g. proxies authorised to receive packages.

Legal basis: processing is necessary for the purposes of the legitimate interests pursued by the controller (art. 6 § 1f GDPR)

Processing period: Until cooperation completion or reporting effective opposition by the data subject.

- **The purpose of processing details:** Transmission of offers-related and marketing information in the case of electronic transmission and processing of the pictures taken during the Race.

Legal basis: the data subject has given consent to the processing of his or her personal data (art. 6 § 1a GDPR)

Processing period: Until the withdrawal of consent.

3. Personal data of not more than the first 10 Participants in each category will be processed by up to 3 years from the end of the Run.

4. After the processing is completed, the name and surname will be anonymised.

5. Providing personal data and image in relation to execution of the contract (accepted rules and regulations) connecting the parties is voluntary but necessary to register participation and to start in the Run. For other purposes, i.e. sending information about offers and marketing content, in case of sending them electronically - providing personal data is voluntary.

3. Personal data of not more than the first 10 Participants in each category will be processed by up to 3 years from the end of the Run.

4. After the processing is completed, the name and surname will be anonymised.

5. Providing personal data and image in relation to execution of the contract (accepted rules and regulations) connecting the parties is voluntary but necessary to register participation and to start in the Run. For other purposes, i.e. sending information about offers and marketing content, in case of sending them electronically - providing personal data is voluntary.

6. Data will be provided to entities cooperating in the organization of the Run, and if the Parent/Guardian of the Participant expresses consent, also to sponsors, whose current list is available on the website: www.lodzmaraton.pl.

7. The parent/guardian of a Participant has the right to request access to his/her personal data, and the personal data of the child/charge, their rectification, deletion or restriction of processing, as well as the right to object to the processing and the right to data transfer and lodging a complaint to the supervisory authority - the President of the Data Protection Office Personal data, whereas a request to delete personal data is tantamount to the deletion of The Run Participant from the list of participants of the Run and Event and lack of possibility to start in the Run.

8. The parent/guardian of a Runner has the right to make a statement on the withdrawal of consent to the following the processing of personal data provided to him/her and to his/her child or guest at any time by post or electronic mail, according to their own choice. Withdrawal of consent shall not affect the lawfulness of the processing, on the basis of the consent prior to its withdrawal.

9. The provision of personal data is voluntary, but necessary to register participation and to the start of the Participant in the Run.

10. Personal data of the Participants and their parents/guardians will be provided to the entities cooperating in the organization of the Event and the Race, and if the parent/guardian of the Race Participant expresses agreement, also Sponsors and Partners. The current list of Sponsors and Partners can be found under at www.lodzmaraton.pl. The list will be kept up to date with what the parent/guardian of The Run Participant acknowledges this by giving his consent.

11. Personal data of the Participants and their parents/guardians shall be processed until any revocation of the consent by the parent/guardian of the Runner, and then for the period of time necessary to secure possible claims relating to the processing of data.

12. Personal data of the Runners and their parents/guardians will not be processed for the purpose of automated decision-making, including profiling.

13. Personal data of the Runners and their parents/guardians will not be transferred to a third country or any international organisation.

X. Final Provisions

1. The Run will take place regardless of weather conditions.
2. The Organizer provides medical care during the competition on the route and at the finish line of the Run.
3. The Organizer is covered by third party liability insurance. The event, including the Run, is covered by third party liability insurance and accident insurance, any claims in this respect should be addressed to the Organizer. The Organizer does not provide participants with life insurance, health insurance or from civil liability in respect of sickness, accident, injury or death, or losses that may occur in connection with participation in the Run.
4. The Organizer suggests that parents/guardians purchase an individual accident insurance for the Runners.
5. The Run results will be available immediately after the Run at www.sts-timing.pl and the website: www.lodzmaraton.pl.
6. Each Participant is obliged to wear the bib number during the Run.
7. Participants are required to run only along the route marked by the Organizer.
8. During the Run Participants are required to submit to the orders of the municipal services, i.e. Police, Municipal Police, MPC Traffic Supervision and Organizer's services.
9. Time measurement is electronic and made with a chips placed on the inside of the bib number.
10. A Run Participant who shortens the route and bypasses the time measurement points will not be classified.
11. Protests and complaints will be accepted in the written form up to 30 minutes after the completion of the Run in the Run Office. Protests and complaints will be considered up to 3 (three) days after the end of the Run. After this time the results of the Run become official.
12. During the Run and accompanying events a photographic report and video materials will be made. The parents/guardians of the Run Participant during registration agree to the use of their image and the image of the Participant; and processing personal data. Failure to agree will prevent registration and participation in the Run.
13. The Organizer reserves the right, and the parent/guardian of the Runner agrees, to conduct an Interview with each Participant and his/her parent/guardian, taking pictures and filming for advertising and promotional purposes, the usage of these materials on the Internet or on radio and television broadcasting and for other commercial purposes.
14. The Organizer reserves the right, and the parent/guardian of the Runner agrees, to free of charge and worldwide use of all photographs and film materials, interviews and sound recordings of parents/guardians of the Run Participants, as well as Run Participants. They can be used by the Organizer by placing on CD, DVD, in catalogues and media, on websites, in newspapers and magazines and at exhibitions, as well as for promotional and advertising purposes related to the activities of the Company conducted by the Organizer.
15. Participants, supporters and accompanying persons are not allowed to enter the Run with intoxicating, illegal substances that increase physical performance and alcohol. Participants are prohibited from taking such substances both before and during the Run under the threat of foreclosure, exclusion from the Run and disqualification.

16. The Organizer is not responsible for items lost during the Run.
17. Only participants with the start numbers placed prominently on the chest may be on the route during the Run. Participants without start numbers and accompanying persons on bicycles, rollers, skateboards and other mechanical devices will be removed from the route.
18. For safety reasons it is forbidden to bring on the route, around the start and finish of the Run items that may pose a threat to other Participants or fans and people accompanying.
19. It is forbidden to participate in the Run in clothing that covers the face and prevents identification of the Participant.
20. If the Run is postponed, not due to the Organizer but due to force majeure, and rescheduled to another date Participants may start in the Run at the given new date, within the paid start fee. The new Run date will be announced no later than within 30 (thirty) days from the date of notification of the need to postpone the Run. In such case the resignation from the Run and refund of fee can be made on Participant's request in accordance with the rules set out in paragraph 22 below.
21. Parking lots will be available for participants of the Run (free and paid) - access from Al. Unii Lubelskiej in Łódź.
22. The Organizer reserves the right to amend the regulations no later than on 05 April, 2022. Each change of the rules and regulations will be posted on the website with an indication of the initial date of its coming into force, no later than 05 April, 2022, at least 14 days in advance. The parent/guardian of the Participant who does not accept the change of the regulations has the right to resign from participation in the Run within 7 (seven) days from the date of its coming into force. Resignation from participation in the Run along with an indication of the bank account number to refund the fee should be sent by registered mail with a return confirmation of receipt to the following address: Association "Maraton Dbam o Zdrowie" ul. Zbąszyńska 3, 91-342 Łódź or electronically to the e-mail address: stowarzyszenie@pelion.eu. In the event of resignation from participation in the Run due to the above-mentioned reasons Organizer shall pay the Participant a starting fee within 7 (seven) days from the day of the delivery of the Participant's statement on resignation from participation in the Run. Technical and organizational changes, including changes in limits, times, number of participants or Run Event Office opening hours do not constitute a change to the Regulations entitling to the refund of the paid fee.
